The meeting was called to order by Bushard. All members of the Board were in attendance. The POA was given.

A motion was made to approve the agenda with the addition of Letter to County on Intersection of County Road 8 and 40 under Old Business. (m- Fred Krafthefer, s- John Krafthefer, v- unan)

## OLD BUSINESS

### Road Report

Bushard contacted the township attorney regarding township road classification. He was told that once a township road is designated it stays a township road. However, if unmaintained for 25 years the people living on the road must build the road back up to standards and petition the township to take the road over again. Vacating a road is difficult to do. This was researched do to all the traffic Darrel Saathoff was getting at the end of Bay View Road , but he has removed the realtor listing and the traffic has decreased significantly.

Central Specialties does not do soft spot repairs as part of the road project so Paz is back finishing up these areas. We have a call into Central Specialties to blacktop a small parking area and sidewalk at Pioneer Park.

### LP Gas Supplier

Bushard called local propane suppliers to get quotes on propane as well as placing a 500 gallon tank at Pioneer Park for the winter. After discussing the options a motion was made to go with Hi Way Amoco (m- Fred Krafthefer, s- John Krafthefer, v-unan)

### Blacktop Update

A question came up as to whether Central Specialties is going to send a crew around to do driveways and/or aprons? The township currently has a call into Central

Specialties to see if they would give us a bid to do a parking area and sidewalk to the door at Pioneer Park.

Letter to County Regarding Junction of County Road 8 and 40

The clerk read a draft letter that will be sent to the county commissioner's office supporting a 4 way stop at the intersection of County road 8 and county road 40. The board would not support a round-about.

NEW BUSINESS

Barrows Review and Hearing

Bushard went to the viewing and hearing where a variance was requested for the addition of a deck not meeting the setback to the lake. The township supported the county's decision. The Variance was granted.

Timber Shores Road and Ditch

We will need to address the water issue in the near future. Recent heavy rains have been washing the roadway out. Possibly a culvert to move the water to the over side of the roadway before it fills in the culvert further down with gravel.
