

Official Minutes of  
Moe Twp Board of Supervisors  
June 5, 2023

The meeting was called to order by Bushard. All members of the Board were in attendance. The POA was given.

A motion was made to approve the agenda with the additions of Culverts – Twilight/Browns/Century to New Business. (m- Jerome Kostreba, s- John Krafthefer, v- unan)

## OLD BUSINESS

### Road Report

The County applied chloride to East Moe, all of Moe Hall Rd, Pioneer Park and Browns Rd.

We should be able to start applying chloride if Fergus Power Pump has any to pick up.

### Tree Trimming

There are more trees that need trimming besides the ones that Kronberg's Tree Service trimmed on Moe Hall Road.

### Road Signs

New and replacement road signs have been installed.

### Alex Lane Update

Tim Erickson was out to look Alex Lane. He said we should get an engineer to see how deep the muck is. Without having borings to see how deep the muck is Tim Erickson provided a ballpark estimate of just under \$35k which included digging out 2 feet of roadway for 800 feet, putting down road fabric, then put in 2 feet of sand followed by a foot of gravel. This would also lift the road about a foot.

We will talk to engineers, Widseth, Smith and Nolting and Jeremy who did Red Pine Ridge.

A motion was made to recognize Alex Lane as a road by dedication of use. (m- Jerome Kostreba, s- John Krafthefer, v- unan)

## NEW BUSINESS

### Spray Road Ditches

We have requested quotes from 3 different businesses. We received 2 quotes back. L&M Road Services quote was \$130/hour and Carr's Tree Service quote was \$203/hour.

A motion was made to have L&M do the work. (m- Jerome Kostreba, s- John Krafthefer, v- unan)

### Sale of Suzuki Truck

Since we do not have a title for the Suzuki truck, the auction house will not list it for us. Brian Sletto offered to let us list it on his K-bid site. A motion was made to sell the Suzuki truck on Brian Sletto's K-bid site. (m- Jerome Kostreba, s- John Krafthefer, v- unan)

The board authorized Fred Krafthefer to drop it off at Brian Sletto's warehouse.

### Black Top Patches

We have a few areas where the black top is breaking up that we will need to repair. These are on Mosquito Lane, Tall Timbers and Cherry Point.

### Culverts – Twilight/Browns Rd/Century

Browns Road culvert is plugged and needs to be cleaned out to view it and determine what repairs, if any, need to be done. There are 3 culverts on Twilight, 1 will need to be jetted out, the other 2 will need varying degrees of repair and the ends need to be reset. There are 2 culverts on Century Road that have the ends sliding away that will also need the ends reset.

Kyle Krafthefer quoted us \$170/hour for himself and 1 additional person plus the mini excavator rental. A motion was made to repair the culverts on Brown's Road, Twilight and Century Road having Johnson Jet-Line clean them out and Kyle Krafthefer do the repair work. (m- Lynn Bushard, s- John Krafthefer, v- unan)

### Shop Plans

Regarding who can vote on the new shop, since the state statutes states that the electors may vote, however the state does not define who exactly an elector is, therefore the board will allow any Moe Township property owner to vote on a new shop.

Kyle Nieland offered to meet with Lynn to put a list of specifics together so apples to apples quotes can be obtained in response to a request for proposal for a new shop.
